PART I**ANIMALS RUNNING AT LARGE****SECTION 2-101. Definitions.**

1. Animal or Animals shall mean any dog or cat and all other domesticated or non-domesticated animals.
2. Enforcement Officer shall mean any police officer or other law enforcement official charged with upholding the laws of the Borough and any officer or official designated or appointed by the Borough Council for control of animals or enforcement of this ordinance.
3. Subsequent Offense shall mean any offense or offenses occurring within two (2) years of a prior offense or offenses.
4. Owner shall include the individual or individuals who hold legal title to the animal and in the case of a minor child holding legal title it shall also include the parent, parents or legal guardian of the child or such other person who has actual custody or control of an animal.
5. Waterfowl is defined as the giant race of Canada Goose and Mallard duck.

SECTION 2-102. Prohibitions.

1. Running At Large. No animal shall be permitted to run at large or upon any public street within the Borough or upon property other than the property of the owner.
2. Annoying Noises. No owner shall allow any animal to make any loud, harsh or annoying noises or other disturbances that would interfere with the peace, quiet, rest or sleep of any persons within the Borough.
3. Desecration. No owner shall allow any animal to defile, corrupt or desecrate any sidewalk, street or property owned by another person nor shall an owner allow any animal to destroy or damage any property owned by the public or another person.
4. Animal Excrement. No owner shall allow any animal to defile, corrupt or desecrate any sidewalk, or street or property of another by allowing an animal to leave excrement or waste thereon. An owner shall immediately remove any excrement or waste left by an animal from any sidewalk, street or property of another.

5. Feeding of Waterfowl. No person shall feed, cause or permit to be fed or provide food for ducks, geese, and/or waterfowl within Harmony Borough.

SECTION 2-103. Penalties.

Any owner convicted of violating the provisions of this ordinance shall be sentenced to the following penalties:

1. First Offense - payment of a fine or not more than \$50.00 nor less than \$25.00 and/or imprisonment for a term not to exceed seventy-two (72) hours.

2. Second Offense - payment of a fine of not more than \$100.00 nor less than \$50.00 and/or imprisonment for a term not to exceed thirty (30) days.

3. Third Offense - payment of a fine of not more than \$300.00 nor less than \$100.00 and/or imprisonment for a term not to exceed ninety (90) days.

PART II**HUNTING****SECTION 2-201. Hunting Prohibited.**

For the Health, Welfare and Safety of the Inhabitants of the Borough of Harmony, the hunting or hunting and killing of any wild bird or animal within the geographic confines of the Borough of Harmony is hereby prohibited.

SECTION 2-202. Penalties.

Any person violating the provisions of this Chapter and Part shall be guilty of a summary offense, and upon conviction of same before a Magistrate shall be subject to the payments of the costs and a fine not exceeding \$300.00 or imprisonment for not more than ninety (90) days, or both.
