## MINUTES:

Russ Ottney requested scratching "Wood Street" from the motion of the boat launch from the April 5 minutes. Dave Szakelyhidi made a motion to accept the April 5, 2005 minutes as revised. Russ Ottney seconded the motion. Motion carried.

Dave Szakelyhidi made a motion to hire someone to fix the bricks at the front of the Borough Building and not to exceed \$300.00.

Jeff Smith requested that the Physical Asset Committee look at some of the storm drains. Discussion on storm sewers that need opened and cleaned out. Dave Rogers made a motion that the Sewer Authority look into it and get a cost on it. He withdrew his motion.

Dave Rogers made a motion that the Attorney look into Boca and see what the benefit is for this community of 800-900. He withdrew his motion.

Dave Rogers questioned Bill Hummel's letter concerning the parking lot (behind the log house) and why doesn't he require a dust free surface.

Jeff Smith stated that Bill Hummel reported on Creekside. He went to the Jackson Township meeting.

# **PUBLIC SAFETY:**

A meeting was held with the police chief. He reported that there were 40 arrests in Harmony. The Neighborhood Crime Watch is going back into effect. Cost of crime Watch Signs is needed.

Russ Ottney made a motion to have Corey look into number of signs needed and the price. Dave Szakelyhidi seconded the motion. Motion was withdrawn.

German and Spring Street crosswalks need painted.

The Police Department is getting new radios.

It was pointed out that there are two ordinances that concern junk cars.

- 1. A junk car ordinance
- 2. A nuisance Ordinance that deals with junk cars.

#### PARKS:

Julie Habsburg and Diane Smith are going to a Grant Writing Seminar in June.

The Planning Commission recommended approving the Zoning Ordinance.

#### **OLD BUSINESS:**

Concerning the Such Hearing.

Dave Rogers made a motion that he is not guilty. Harold Herr seconded the motion. Discussion. Dave Rogers stated that Such's can't get hold of MDIA and Mr. Such has cleaned out the garage. Motion carried.

Ralph McCormick sent a letter to Council requesting a handicap sign be put up for him at the turn around.

Dave Rogers made a motion to put a temporary handicap parking sign on the South side of the turn-around. Russ Ottney seconded the motion. Motion carried.

Harold Herr made a motion to close the Capital Improvement Fund and the Escrow Account and open an EMS Account. Gary Habsburg seconded the motion. Discussion.
