MARCH 16, 2006 MEETING CONTINUED FROM MARCH 7, 2006

COUNCIL MEMBERS PRESENT: John Rice, Jeff Smith, Gary Habsburg, Harold Herr, Mayor, Cathy Rape

The March 7, 2006 meeting was continued March 16, 2006 at 7:15 PM.

Attorney Matthew Marshall brought to Council's attention that Michael Wearing's attorney stated that they were willing to settle out of court for \$15,000.00. Attorney Marshall also stated that the Borough was in its rights to terminate Charles Wearing as a Borough Employee. The \$15,000.00 will be paid by the insurance company.

Gary Habsburg made a motion to approve the settlement and accept the agreement. Harold Herr seconded the motion. A provision will be required to be confidential on Mr. Wearing's end. Motion carried.

Jeff Smith stated that he has applied for a \$700,000.00 grant to allow the Borough to replace the water towers. The School District has supported the grant. All municipalities will benefit.

Harold Herr made a motion to write a letter requesting support from the other municipalities. Gary Habsburg seconded the motion. Motion carried.

Jeff Smith also brought to Council's attention that the free website time has come to an end. Gary Habsburg made a motion to spend \$50.00 or less a month to enter into an annual subscription for the web site. Harold Herr seconded the motion. Motion carried.

Cathy Rape stated that John and Jan Helbling donated 44 wreaths and sprays to the Borough for Christmas decorations. Council agreed that they can be stored in the water garage. Mayor Rape also stated that Penn Power has agreed to pay for the Harmony fireworks.

John Rice discussed putting an open ditch on Mercer Street instead of running a camera up the pipe. John made a motion to authorize Bill Hummel to come up with plans for the Mercer Street storm water project. Gary Habsburg seconded the motion. Motion carried.

John Rice made a motion to pay the Holbein Bill in the amount of \$4,200.00 for repair work on the walking trail and a motion to pay the Blinn Brothers' bill for repair work to the Jackson Street storm drain (bid amount \$4,975.00) and rip rap at the bridge (bid amount \$975.00). Harold Herr seconded the motion. Motion carried.
