Streets: Discussion concerning installing a collection box on Charles Street. John Rice made a motion to put in one of our own 2X2 collection boxes and enough 12" heavy duty pipe to reach Jackson Township. Russ Ottney seconded the motion. ## **OLD BUSINESS:**

Public Safety: The Zelienople Police are still trying to get mail alert information from the residents.

Discussion on the Wood Street turn-around.

John Rice made a motion to put "No Parking" signs on the south end of Wood Street. Russ Ottney seconded the motion. Motion carried.

Wade Ion requested a new leaf box at a cost of \$3,500 - \$4,000. Harold Herr made a motion to purchase a new leaf box. Dave Szakelyhidi seconded the motion. Motion carried.

Any budget requests need to be in to Gary as soon as possible.

## Public Safety:

Russ Ottney reported on the revisions to the Burning Ordinance. The Safety Committee feels Harmony is as good or better than Zelienople's Burning Ordinance. It needs to be enforced.

Dave Szakelyhidi made a motion to send a letter of support for the fire merger study. Russ Ottney seconded the motion. Motion carried.

Dave Szakelyhidi commented on the list of everything that was built in the Flood Plain since 1989 and that 11 of them are paragon buildings. He stated that the loading dock was closer than 50 feet and in violation of Federal regulations. Attorney Marshall recommended going back and looking at and comparing what was submitted to what was built.

Facilities: Harold Herr made a motion to accept the grant from Penn Prime and purchase a security system. Gary Habsburg, seconded the motion. Motion carried.

Business and Development: Russ Ottney stated that Equitable Gas is looking for new facilities and felt that Harmony should pursue the issue.

Zelienople is looking at information on garbage collection. Gary Habsburg made a motion for Zelienople to include Harmony as an option. Harold Herr seconded the motion. Motion carried.

## **BILLS PAYABLE:**

Harold Herr made a motion to pay all bills as presented. Dave Szakelyhidi seconded the motion. Motion carried.

## PUBLIC COMMENT:

Sandy Rothwell stated that there is an ordinance violation at the Allmans. She now has damage to her property and her basement is flooded. She stated that action needs to be taken.

**John Ziegler** commented on the monuments and condition of the flags. He presented a new flag and stated that he would present a new flag every quarter or every 6 weeks if needed.

Carl Marburger discussed Clyde Alley and the portion that is closed. Attorney Marshall will look into it.

Diane Marburger questioned how wide 3rd Street will be. John Rice answered 20 feet.
