AN ORDINANCE OF THE BOROUGH OF HARMONY, BUTLER COUNTY, PENNSYLVANIA, ESTABLISHING A SPECIAL SCHOOL ZONE SPEED LIMITATION BEGINNING AT THE INTERSECTION OF PITTSBURGH STREET AND EAST BEAVER STREET AND CONTINUING 150 FEET IN THE WESTERN DIRECTION ON EAST BEAVER STREET IN ACCORDANCE WITH §3365(B) OF THE PENNSYLVANIA VEHICLE CODE.

WHEREAS, in order to promote and protect the health, safety and welfare of the residents of the Borough of Harmony, the Pennsylvania Department of Transportation has submitted a permit and diagram for the Connoquenessing Valley Elementary School in order to establish a special school zone speed limitation.

NOW THEREFORE, BE IT ORDAINED AND ENACTED BY THE COUNCIL OF THE BOROUGH OF HARMONY, BUTLER COUNTY, PENNSYLVANIA, AND IT IS HEREBY ORDAINED AND ENACTED BY AND WITH THE SAME THAT:

SECTION 1:

In accordance with §3365(b) of the Pennsylvania Vehicle Code, the Borough Council of the Borough of Harmony hereby establishes a special school zone speed limitation beginning at the intersection of Pittsburgh Street and East Beaver Street and continuing 150 feet in the western direction on East Beaver Street.

SECTION 2:

The special school zone speed limitation shall be 15 miles per hour during the following time:

Monday through Friday

7:45 a.m. to 8:45 a.m.

11:15 a.m. to 12:40 p.m.

3:00 p.m. to 4:00 p.m.

SECTION 3:

The erection and maintenance of all necessary signage is hereby authorized. Said signage shall be placed so as to properly notify all vehicular traffic of the imposed regulations.

Signage shall be in accordance with Exhibit "A" attached hereto and incorporated herein.

SECTION 4:

Any Ordinance or part of any Ordinance conflicting with the provisions of this Ordinance is hereby repealed to the extent of said conflict.

SECTION 5:

The appropriate Officers of the Borough of Harmony are hereby authorized and directed to execute any and all documents necessary to effectuate the purposes of this Ordinance.
