

ORDINANCE NO 413

AN ORDINANCE OF THE BOROUGH OF HARMONY, BUTLER COUNTY, COMMONWEALTH OF PENNSYLVANIA, AMENDING THE CODE OF ORDINANCES AT CHAPTER 15, MOTOR VEHICLES AND TRAFFIC, §203, STOP INTERSECTIONS ESTABLISHED, TO INCLUDE THE FOLLOWING STOP INTERSECTIONS: MAIN STREET AT GERMAN STREET AND MERCER STREET AT SPRING STREET FOR TRAFFIC.

WHEREAS, in order to promote and protect the health, safety and welfare of the residents of the Borough of Harmony, the Borough Council of the Borough of Harmony, Butler County, Pennsylvania, has determined it necessary to install stop signs at the following intersections: the intersection of Main Street and German Street and the intersection of Mercer Street at Spring Street.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED BY THE COUNCIL OF THE BOROUGH OF HARMONY, BUTLER COUNTY, PENNSYLVANIA, AND IT IS HEREBY ORDAINED AND ENACTED BY AND WITH THE SAME THAT:

SECTION 1: The following intersections are established as stop intersections, and official stop signs shall be erected in such a position as to face traffic approaching the second-named street (the intersecting or through street) on the first-named street (the stop street) in the direction or directions indicated for that intersection.

SECTION 2: Chapter 15 of the Code of Ordinances §203 is hereby amended to include the following stop intersections:

Main Street	German Street	Eastbound
Main Street	German Street	Westbound
Main Street	German Street	Northbound
Main Street	German Street	Southbound
Mercer Street	Spring Street	Northbound
Mercer Street	Spring Street	Eastbound
Mercer Street	Spring Street	Westbound

SECTION 3: The erection and maintenance of official stop signs at these locations is hereby authorized.

SECTION 4: Every driver of a vehicle approaching the intersection of the first named or stop street, in the direction indicated in each case, shall stop the vehicle as required by §3323(b) of the Vehicle Code, and shall not proceed into or across the second-named or intersecting or through street until they have followed all applicable requirements of that section of the law.

SECTION 5: Any person violating any section of this Ordinance shall, upon conviction, be sentenced to pay a fine of twenty-five dollars (\$25.00) and costs.

SECTION 6: Any Ordinance or part of any Ordinance conflicting with the provisions of this Ordinance is hereby repealed insofar as the same conflicts with this Ordinance.

SECTION 7: The appropriate Officers of the Borough of Harmony are hereby authorized and directed to execute any and all documents necessary to effectuate the purposes of this Ordinance.
