**AN ORDINANCE OF THE BOROUGH OF HARMONY, COUNTY OF BUTLER,
COMMONWEALTH OF PENNSYLVANIA, RESCINDING ORDINANCE NO.
430 WHICH CREATED A SPACE FOR HANDICAPPED
PARKING AND DESIGNATING 714 SPRING STREET AS A NO PARKING
ZONE**

WHEREAS, on or about April 2, 2019, the Council of the Borough of Harmony adopted Ordinance No. 430 which created a handicapped parking space at 714 Spring Street, Harmony Borough, Pennsylvania; and

WHEREAS, the Borough is now cognizant of the fact that this practice is not in the best interest of or benefit to Harmony Borough; and

WHEREAS, the Borough has determined it necessary to regulate the parking of vehicles at 714 Spring Street; and

NOW, THEREFORE, be it ordained and enacted by the Council of Harmony Borough that Ordinance No. 430 is rescinded.

Section 1. No Parking.

That hereafter it shall be unlawful to park any motor vehicle or other vehicles at 714 Spring Street.

Section 2. Signage.

The erection and maintenance of all necessary signage is hereby authorized. Said signage shall be placed so as to properly notify all vehicular traffic of the imposed regulations.

Section 3. Enforcement.

It shall be the duty of the police officers having jurisdiction within the Borough to institute the prosecution of all persons violating Section 1 of this Ordinance.

Section 4. Penalty.

Whoever violates Section 1 of this Ordinance, shall, upon conviction thereof, be sentenced to pay a fine of not more than three hundred dollars (\$300.00).

Section 5.

Any Ordinances, or parts thereof, which conflict with the provisions of this Ordinance are hereby repealed.

Section 6.

The provisions of this Ordinance are severable and if any sections, clauses, or sentences shall be held illegal, invalid, or unconstitutional, such provisions shall not affect or impair any of the remaining sections, clauses, or sentences.

Section 7. This Ordinance shall become effective immediately upon enactment.

Section 8. Repealer.

Any Ordinance, or any part of any Ordinance, in conflict herewith is hereby repealed to the extent of such conflict.
